BASIC TERMS AND CONDITIONS

1. Booth reservations must be made in advance of the All American Columbus Pet Expo. A \$150.00 Deposit is required to guarantee space. **This contract is non-cancelable. Deposit and payments are non-refundable.** Payment schedule on this contract must be made on time. If payments are late, All American Pet Expo (referred to as AAPE going forward) retains the right to terminate this contract and resell the space.
2. AAPE will provide security throughout the entire event from initial set-up to final tear down. AAPE will not be liable to the exhibitor, his employees, agents or guests for any damage, loss, or injury from fire, electricity, water, storm, riot, smoke, theft or any other cause.
3. Exhibitor gives AAPE the right to use their name in advertising for The All American Columbus Pet Expo.
4. All displays must remain completely set-up and manned for all hours of the Expo, up to and including 5pm on Sunday. Early teardown is NOT allowed. **VIOLATION OF THIS RULE WILL SUBJECT THE EXHIBITOR TO A \$500 FINE AND AUTOMATIC NON-RENEWAL OF SPACE FOR FUTURE ALL AMERICAN PET EXPOS.** _____ (Please Initial Here)
5. TOTAL COST OF THE BOOTH MUST BE PAID-IN-FULL 30-Days prior to the first day of the Expo. ALL EXHIBITORS PAYING AFTER THE DEADLINE ARE SUBJECT TO PAY A 10% LATE CHARGE. (CALCULATED ON THE TOTAL OF THIS CONTRACT). AAPE reserves the right to hold a company's inventory in the event of non-payment due to AAPE for rent of tables, electric, decorator items, or monies due.
6. All exhibitors must be set-up and ready for business ONE HOUR prior to the Expo. All exhibitors arriving late for their designated set-up time will be subject to a new set-up time as approved by AAPE. **NOTE: EXHIBITORS WILL NOT BE ALLOWED TO SET UP ANY DISPLAYS OR MERCHANDISE IF ALL RENT AND MONIES DUE PER THIS CONTRACT HAVE NOT BEEN PAID IN FULL ON OR BEFORE THE 30-DAY DEADLINE, PRIOR TO THE FIRST DAY OF THE EXPO.**
7. All products and services to be sold/promoted must be listed in writing on an attached sheet that is subject to final approved by AAPE, if space is inadequate to list them all on the Exhibitor Contract. AAPE reserves the right to stop the sales of products/services not approved on the contract or attached list. Failure to cease sales of unapproved products or services will subject exhibitor to immediate removal from the Expo.
8. No product exclusives will be honored unless specified on Line 16 of this Terms/Conditions Contract and approved with the initials of the AAPE Representative.
9. Devices that produce sound must be operated so as not to disturb other exhibitors. AAPE will determine acceptable sound levels.
10. It is agreed that any litigation regarding this contract shall be litigated in the appropriate Court in The State of Ohio.
11. Participation in the AAPE is subject to final approval by Steve Cantin Productions, LLC. Subletting or sharing of space in any form is prohibited unless explicitly written in on Line 16 and signed by an authorized AAPE Representative.
12. AAPE reserves the right to resell and cancel any contract not paid in full by 30-days prior to the first day of the Expo. **Deposits and payments on the contract are non-refundable** and will be considered payment for resale cost if the contract is resold due to failure of the exhibitor to pay in full by the contractual due date.

13. Exhibitor agrees that commencing on the date of occupancy provided in this Exhibitor Agreement and thereafter during the period of occupancy, shall maintain such insurance in the amount of \$500,000.00 as will protect exhibitor, Columbus Pet Expo, All American Pet Expo, and the Ohio Exhibition Center, its members and staff from claims under Worker's Compensation Acts and other Employee Acts; from claims for personal injury, including death, and from claims for damages to property which arise out of or results from exhibitor's operations under this Exhibitor Contract. Exhibitor shall provide All American Columbus Pet Expo at least forty-five (45) days prior to the first date of the Expo, with evidence that it has comprehensive general liability insurance for bodily injury and property damage from a solvent company licensed to do business in the State of Ohio.
14. The responsibilities of AAPE are limited to those listed in this contract. AAPE shall not be held liable for any promises made by any of its representatives in the event of non-payment; this contract becomes the sole responsibility of the signer.
15. AAPE agrees to advertise the All American Pet Expo sufficiently utilizing TV, Radio, Print & Social Media. Use of the name All American Pet Expo, Columbus Pet Expo, All American Columbus Pet Expo or the Pet Expo trademark without the written approval by Steve Cantin Productions, LLC will be cause for removal from the All American Columbus Pet Expo and immediately voids this contract. Any use of the name All American Pet Expo or the trademark in advertising or promotion at any time by a contracted exhibitor must be approved by Steve Cantin Productions.
